The courts are not immune to corruption. [History proves it.](#) Sadly, it is not as rare as it should be. It has increased in the recent decades. I could bore you with many more but I believe I have made my point.

Another point: anyone who complies with this clearly illegal court order is committing the crime of [accessory to embezzlement after the fact](#). AND? Mr. Beloin is a witness in a mob hit ordered by a NH District Court Judge Kerry Steckowych. He has the order on tape. If this clearly illegal court order has anything to do with Mr. Beloin helping me expose judicial

corruption, any actions associated with this clearly illegal court order could be [accessory to murder after the fact by proxy](#). This may seem a bit extreme to the lay person but there are many precedent setting cases supporting the disobeying of an illegal court order. Not only is it perfectly legal to disobey an illegal court order, you can be prosecuted for obeying an illegal court order. I will list two precedent setting cases.

1. Every Jew that died in WWII Germany died legally under the laws enacted by the state. Every soldier who obeyed those laws and court orders supporting them were hunted down after the war and prosecuted. Every one used the same defense. ***"We were just following the law. We were just obeying court orders."*** Everyone of them was convicted and hung or sentenced to life in prison.
2. In NH the precedent setting case is that of State of NH V Gerard Beloin - 214-2012-CR-00121. Hillsborough County Superior Court Judge Diane Nicolosi repeatedly issued clearly illegal court orders based on proven forged and falsified court records. **The same as in my case.** As in my case, the illegal court orders were so brazen that law enforcement refuse to enforce them. The Coos County Superior Court cleared Mr. Beloin of all charges. All of his rights, his properties and thousands of dollars illegally seized from him were returned to him.

In my case, a quarter of a million dollars was embezzled by my ex husband from my retirement savings. I have the accounting. The proof is linked below in an e-mail to NH District Court Chief Justice Ellen Christo. 1. Mitchell is kicking back a part of the quarter of a million embezzled from me to Judge Elizabeth Paine in order to obtain a favorable ruling from her.
2. The courts don't want to give my paralegal another win. Mr. Beloin has repeatedly embarrassed the courts in the past by exposing judicial corruption and winning his cases.
